

# Regulations of the special offer "-50% for 6 months!"\*

# 1. Period:

1.1. From 01.08.2022 to 31.05.2023

1.2. Promotional period - 6 months (month of connection + 5 subsequent months). The period during which the subscriber can use the services on the discount specified in clause 3.2 of this regulation is implied.

## 2. Participants:

2.1. Potential subscribers who live in apartment buildings and wish to connect to the services of "Internet", "Internet + TV" or "Internet + Web TV" (subject to technical feasibility) and are not subject to section 6 "Exceptions".

2.2 Tariff packages participating in the promotion:

\* An additional 100 Mbps is provided, subject to the technical capability of the subscriber and the company.

## 3. The essence of the special offer:

3.1. Residents of the city of Kharkiv and the region (areas where there is a technical possibility of connection) during the period of the special offer can order the service specified in clause 2.1 on promotional terms.





Special offer conditions: during the connection month and the next five months, the subscriber pays the cost of the tariff plan with a 50% discount. After the end of the promotional period, the amount of the subscription fee will be standard (without discount).

### 4. Connection process

4.1. The subscriber calls the service-information center on the multichannel phone (057) 720-9-720 or 0800-31-0700 and leaves a request for connecting services under the special offer "-50% for 6 months!" You can also leave an application on the maxnet.ua website or on the company's Internet resources.

### **5. Connection conditions**

5.1. The cost of connection, cable inside the apartment and additional equipment is paid according to the current price list of the "Maxnet" company.

5.2. At the time of the Promotion Period, subscribers cannot participate in existing loyalty programs.





## 6. Exceptions

6.1 The following cannot participate in the promotion:

- legal entities;
- existing subscribers wishing to connect a second point to the same address;
- subscribers who terminated the Agreement during the promotion period;
- subscribers who already take part in promotional offers from Maxnet
- persons who are subscribers of "Maxnet" within the last 3 months.
- subscribers, connected to the PON net in private sector.
